

TERMS AND CONDITIONS OF THE MUSIC COMPETITION “String your soul”

1. Term of the competition:
 - a) The application for participation in the online music competition “String Your Soul” hereinafter called the Competition is by writing and recording the music for the preliminarily provided lyrics by the Organizer as mentioned in Part 4 of the following Terms and conditions and uploading it to the website www.GIILife.com, hereinafter called [GIILife](http://www.GIILife.com) for brevity. The application will run from 00:00 (+2GMT) on 1.03.2016 until 24:00 (+2GMT) on 09.06.2016. After the referred date in this Article (09.06.2016) no further entries will be permitted. The voting will start at 12:00 (+2GMT) on 10.06.2016 and ends on 22.06.2016 at 00:00 (+2GMT). The voting will be through the system of likes from registered users of the website [GIILife](http://www.GIILife.com). The number of likes will not be visible until 18.06.2016 (at 12:00).
2. Name of the contest - “STRING YOUR SOUL”.
3. Organizers of the contest: “Grace P” Ltd. with headquarters 130 Kniaz Boris I Str., 1000, Sofia, Bulgaria.
4. The competition consists of writing the music for the song “Awesome God” with the original lyrics by Rich Mullins. Creating and uploading a video of the Participant which is their own work and they own the copyright for it. For more information as to whether you qualify as a Participant refer to Part 6.
5. The competition will be held in two successive rounds. The first round - Round 1, will end with an evaluation of the recorded songs through the system of votes on the [GIILife](http://www.GIILife.com) in the form of likes. The Participants with then proceed to Round 2, which is also the final round in the Competition. Round 2 will consist of an event held by the Organizer, the details of which (place, date and time) will be announced on the webpage [GIILife](http://www.GIILife.com). The Organizer will invite to the event the Participants to perform live the songs of their own work which they recorded for the Competition as laid down by Part 4. This round will end with an evaluation from a panel of jury, which has been preliminarily chosen and announced on the page of the Competition. If it is

impossible to reach one or more Participants for the day of the event they will be automatically eliminated and will lose the chance of participating in the Competition. Upon the judgment of the Organizer a Concert might not be held. In this case the Competition will proceed to voting and choosing a winner by both jury votes and the number of votes on the website as laid down by Article 8.2.

6. Participants in the competition:

6.1. Participants in the competition can be only bands **with at least 3 members**, who have been assembled either prior to the competition or who are assembling in order to participate in the competition. Solo artists and duets cannot take part in the Competition. For brevity hereinafter a band will be called a Participant.

6.2. Participants in the competition can be only natural persons forming a band and who are or have registered in the [GIILife](#) website within the term of the competition.

6.3. Employees of “Grace P” Ltd., their relatives and their families are not allowed to participate in the competition.

6.4. Territory: The competition is held online, so Participants are welcome to submit their entries from any country in the world. In case one or more Participants reside outside the Bulgarian Republic - where the Organizer will hold the event, in order to attend the event will be responsible for all travel costs for all members of the band, the transportation of their equipment and any other expenses. The Organizer will not be responsible for covering the expenses or for the inability of a Participant to attend under any circumstance.

6.5. Prize: There will be only one prize in the Competition, which will be rewarded to the winning Participant amounting to BGN 5,000.

7. Competition mechanisms:

7.1. In order to take part in the competition, each Participant has to register in the [GIILife](#) website.

7.2. After successfully registering the Participant will have to write the music to the song “Awesome God” as laid by Part 4. The Participant should shoot and upload the video of their own titled “Awesome God” in the Section “String Your Soul” in the [GIILife](#) website and beneath the material state the name of the band and the three names of each member of the band. The video material for the song should be recorded especially for the Contest and should not have been shown in its entirety or parts of it before.

7.3. The Participants have to upload the copyrighted material, which is their own work before 00:00 o'clock on 09.05.2016 in the [GIILife](#) website following the instructions on the website.

7.4. Each Participant, who complies with the conditions laid down by Part 1 to Part 6 from the Terms of the Competition will automatically become a Participant in the competition and qualifies for the award nomination complying with the terms in Part 1 to Part 6.

8. Determination of the promotional prize:

8.1. There will be only one Winner as laid down by Part 6.5. The winning band will be called the Winner for brevity hereinafter.

8.2. The Winner will be determined **partly** according to the number of likes their uploaded material has received in the GII network that complies with the terms and conditions and according to a jury panel which is assigned by the Organizers. The share of the votes of the jury is 40% and the share of the votes through likes is 60%.

8.3. The award announcement will take place on the date of the event which will be preliminarily appointed and announced on the [GIILife](#) website.

9. Award of the prize:

9.1. The Winner will be picked on the date of the event and will be handed the prize by the Organizer on the same date.

9.2. Before the event the members of the bands have to identify themselves to the Organizer with their identification cards/passports.

9.3. All under-aged Winners need to present an identification card and have to be accompanied by at least one parent or foster parent, who can certify their relationship or custody.

9.4. The prize shall be certified by signing a take-over record by the participant and a representative of the Organizer.

9.5. In case, that one or more bands of the bands does not appear on the date of the event to perform live, they will lose their right to compete in this second Round and the Round will be held nonetheless.

10. Additional provisions:

10.1 By uploading copyrighted material of their own in the section "String Your Soul" in the website of the competition, each Participant accepts these General conditions and gives "Grace P" Ltd. voluntarily their personal details, which are necessary for the

participation in the competition, as well as their agreement for these details to be stored and processed by the Organizers, and the copyrights of their materials, all in compliance with the provisions in the law of the personal data protection.

- a. There is no entry fee and no purchase necessary to enter the Competition.
- b. No responsibility can be accepted for entries not received for whatever reason.
- c. The Winner agrees to be photographed, recorded and to participate in public events of the Organizer with advertising nature, without receiving additional rewards for that.
- d. The Organizer has the right to amend at any time these Terms and conditions. All amendments will enter into force, once they are published on the [GIILife](#) webpage.
